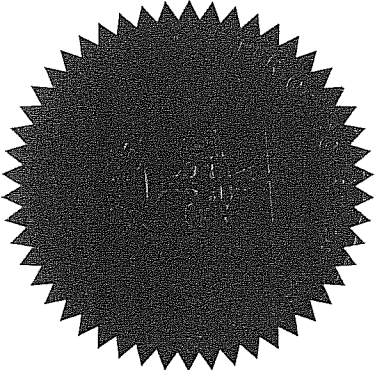

THESE MOTIONS, made by the Plaintiff, the Attorney General for Canada, and the Third Parties were heard on April 1st and 2nd, 2008, at 361 University Avenue, Toronto, Ontario, reasons having been released on the 2nd of April, 2008, costs being reserved and released this day,

ON READING the costs submissions of the Plaintiff and OHIP, the Third Parties, and the responding submissions of the Attorney General of Canada filed herein,

1: **THIS COURT ORDERS** that costs for the motions by the Plaintiff to amend her pleading and to stay or sever the third party claims are fixed at \$5,000 in the aggregate for the Plaintiff and \$1,000 for OHIP;



2. THIS COURT ORDERS that there be no costs for the motion by the Plaintiff to amend its litigation plan and notice of certification;

3. THIS COURT ORDERS that costs for the motion by the Attorney General of Canada to strike paragraphs of the Plaintiff's statement of claim and reply are fixed on a partial indemnity basis at \$10,500 for the Plaintiff and \$1,400 for OHIP;

4. THIS COURT ORDERS that costs for the motion by the Third Parties to strike the Attorney General of Canada's third party claims are fixed at \$8,500 for each of the Third Parties; and

5. THIS COURT ORDERS that the above amounts are inclusive of disbursements and GST and are to be paid, ~~with~~ ^{with} 30 days of release of this endorsement,

to the date of this Order.
